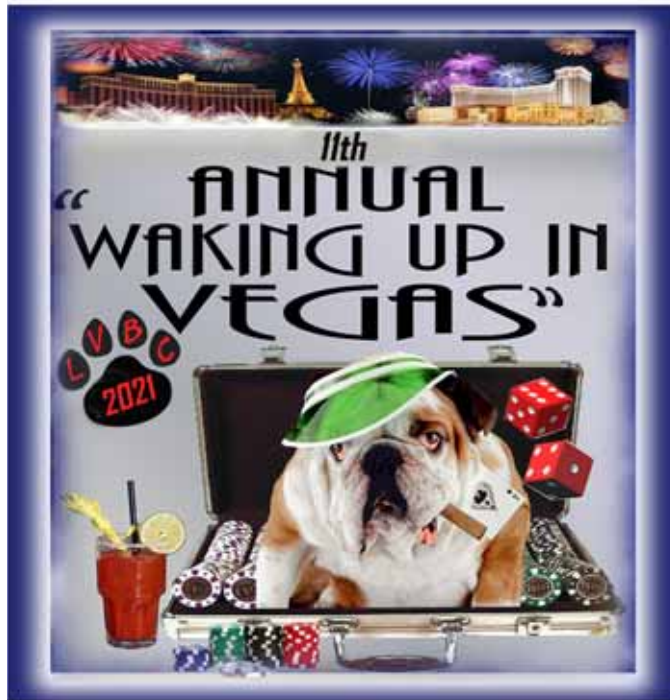

This class is restricted to exhibitors who have not, at any point in time, been a professional dog handler, AKC approved conformation judge, or employed as an assistant to a professional handler. Additionally, members of the immediate family or household of a current professional handler are ineligible for this class (as defined in Chapter 11, Section 13).”

NOTICE TO EXHIBITORS

If, because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or to complete the show, no refund of entry fees will be made.

A recording fee of 50 cents and an AKC Event processing fee of \$3.00 will be required for each dog entered at any licensed or member club show, obedience trial or tracking test. These fees are to be collected by the show-giving club, and paid to the American Kennel Club. If a dog is entered in more than one class at the show, the recording fee and event processing fee is to be collected on the first entry only. (AKC Rules, Chapter 14, Sec. 2)

Ribbons must be claimed the day of the show or be forfeited.

No entry shall be made and no entry accepted which specifies any condition as to its acceptance. Telephone and Telegraph entries cannot be accepted. Entries must be submitted on an American Kennel Club Official Entry Form or exact copy (both front and back).

Owners are responsible for errors on entry blanks. The Club and/or its Show Secretary assume no responsibility for wrong or incomplete information given on the entry blank by the owner or owner's agent entering a dog or a class for which the dog is not eligible to compete.

Entry fee shall not be refunded in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge or barred from competition by action of the Show Committee or because it has been entered incorrectly.

No dogs will be allowed in the show limit area except those regularly entered in the show.

Dogs must be ready for Judging. The club and its Show Secretary will not be responsible and are not obligated to furnish any service for notifying exhibitors or their agents of breed or class judging. The Judges will not wait for any dog holding up a class.

This club will not be responsible for the loss of or damage to any dog exhibited, whether the results of accident or other causes. It is distinctly understood that every dog at this show is in the care, custody, and control of his owner or handler during the entire time the dog is on the show premises. The club will not be responsible for injury to any person attending this show.

A dog which according to their owner's record have completed the requirements for a Championship after the closing of entries for the show, but whose Championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety competition, provided this transfer is made by the Superintendent or Show Secretary at least one half hour prior to the start of any regular conformation judging at the show.

ADDITIONAL RULES

Exhibitors must not wear pins or badges identifying them with any club or organization. Crates and grooming tables will not be allowed within 10 feet of the rings. Dogs may arrive any time prior to the scheduled time of judging. Dogs not required for further judging will be excused. Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging class when their classes are called to be judged. All dogs present must be held on a leash or confined to their crates except when being judged or when in the exercise ring. Class cash prizes will be paid in the ring to the person showing the dog. Claims for prize money must be made in the ring before the judging of the breed is over and the Show Secretary advised at once. The Show Secretary and show-giving club may disclaim any liability for cash prizes after the judging of breed is over.

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In Consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull

Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.

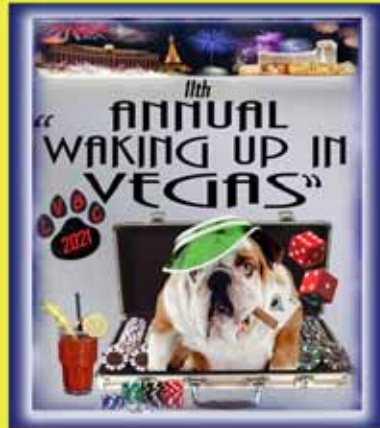
